- This is a no smoking facility
- Absolutely no firearms or weapons allowed
- Any attachments to our property must be fastened with removable tape only. (No nails, tacks, push pins, etc.)
- Attachments are not allowed on the ceiling tiles
- All decorations are to be removed and the building & grounds vacated by 2:30am on the morning following the date of the rental.
- No confetti or like material allowed
- Please replace (cleaned) tables and chairs back into the storage area
- Parking areas must be cleaned of all debris
- All trash is to be bagged and placed in the dumpster
- Check all doors and verify that they are locked
- Replace thermostats to 'off' or at the previous setting
- Make sure that all lights, inside and outside, are off

Tenant is responsible for:

- Returning 'cleaned' tables and chairs back into the storage room
- Bagging and placing all trash in the dumpster
- Cleaning all debris left in the parking lot and grounds
- Returning thermostat to the 'off' position or previous setting
- Seeing that all lights, inside and outside' are off
- Checking and assuring that all doors are locked
- Obtaining any required 'Alcohol Permits' as deemed necessary by ALE
